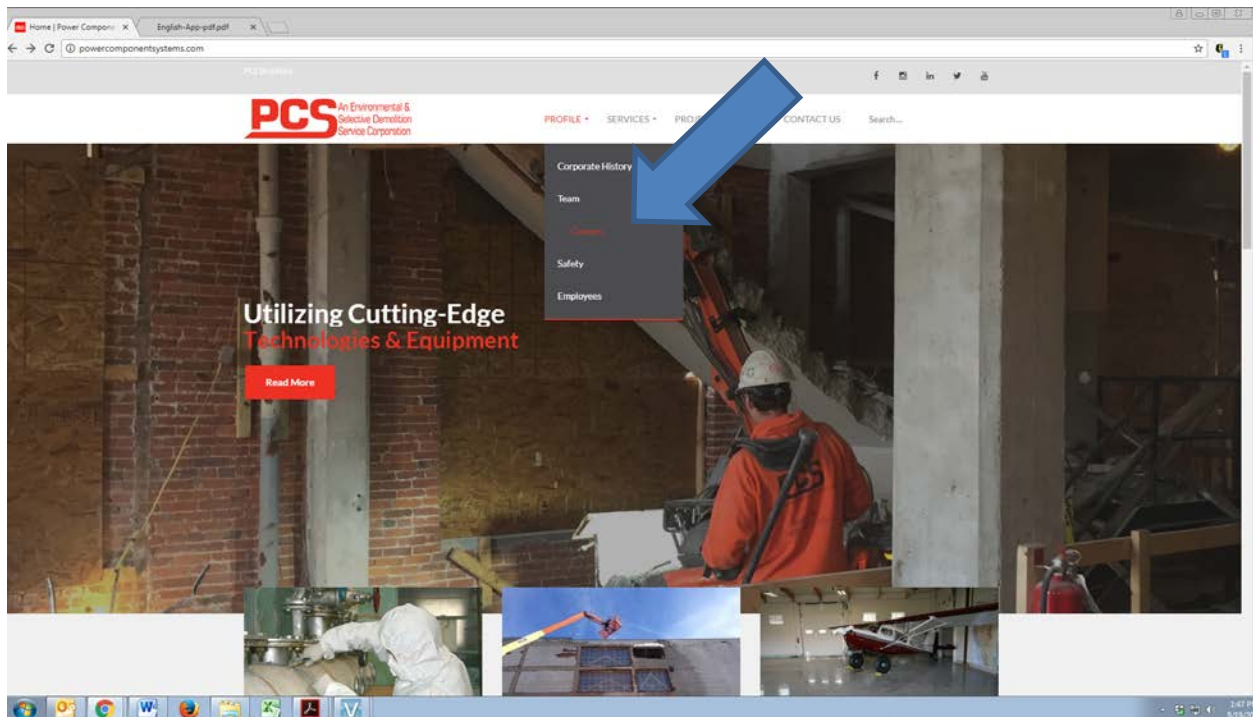




## **Instructions for Completing the Online Application**

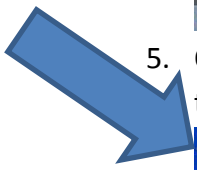

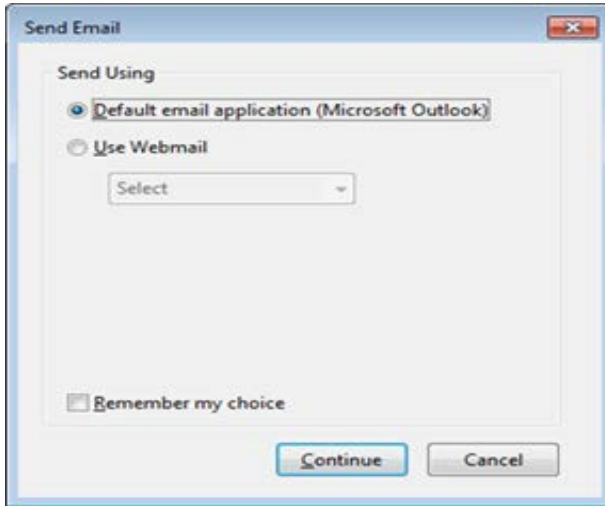
